The Institute conducts its own welder certification under National Welder Training & Certification Scheme (NWTCS), which has been prepared to meet the demand by industry for welders, trained and certified to a level of competency commensurate with the requirements of any of the welder qualification and certification specifications or codes i.e. IS:7310 / IS:817, ISO:9606-1, BSEN:287 and ASME Sec IX/AWS D1.1.

IIW-India has also been empanelled by Government of India, DGE&T (Directorate General of Employment and Training) as an Assessing Body for all Fabrication sector courses under their MES-SDI (Modular Employment Skills – Skill Development Initiative Scheme).
