## CIRCULAR FOR INCREASE IN MEMBERSHIP FEES

Dear Members,

### Greetings from IIW-INDIA!

You are aware that your Institute has steadily grown over the years with regard to number of Students' Chapter under various Branches as well as with the activities of individual Branches indicating a steady increase. Memberships in various classes have also been growing rapidly.

Further, it is to be noted that during the last several years, the membership fees were not increased or revised for any categories, whereas, the expenses has increased sharply in almost all areas, e.g. paper & printing cost of the Journal, Stationery and finally the Administrative Costs; our finances are not in a sound position to combat the situation. Considering this, IIW-India Council, after due deliberations of the fact and finally with great reluctance in its 314<sup>th</sup> Meeting held in Kolkata, decided to amend the Bye-Laws No. 7 & 8 of the of the Institute regarding the revision of Entrance Fee and Annual subscription including Life Membership Subscription effective from 1<sup>st</sup> of April, 2020. According to the amended Bye-Laws No. 7 & 8, the consequent changes in the membership fees are as follows:
