Special procedure to qualify by online Transition Arrangement
From IIW-India ANB (Ref Clause 2 of IAB-ASS-065-April 20)

1. **Transition Arrangement to qualify as Welding Coordinator (ISO 17031-2019:**
 - a. The standard operating procedure (OP) require the candidates for IJWE, IWT, IWS & IWP qualifications to physically attend a 5 day refresher course in line with IAB Guideline 252r5-19, followed by passing a written MCQ examination and personal interview/oral examination.
 - b. **Online option:** IIW-India ANB is happy to convey that a temporary facility being allowed by IIW-IAB to conduct online the Transition Route refresher course, examination and interview for candidates sitting at home arising out of the situation (COVID 19 Pandemic) requiring candidates to avoid/not allowed travelling and to maintain social distancing.
 - c. **Eligibility Criteria:** There is no change and the same assessment process will be followed:
2. **Procedure:** Course participation
 - a. **Enrollment:** Approved candidates intending to participate in online Transition Arrangement to qualify will have to make full payment in advance including GST and duly fill-up this Form.
 - b. **Online Video Platform:** The on line delivery will be using Google Meet Platform or any other suitable platform for course & examination which will be intimated to candidates in advance
 - c. **Hardware, Software, Broadband:** Candidates must ensure the availability of suitable hardware with camera and microphone, adequate processor and RAM and have adequate data package. *This is solely the responsibility of the candidate. They must check and test the system prior to participation.* Each 2 hr. module may consume 3-5 Gb as indication and we suggest stable broadband symmetrical connection of about 4-5 mbps or higher.
 - d. **Candidates must use their own Laptop and E mail id.** Office e-Mail id and Laptop, which may have many restrictions on use and official message pop ups, may disrupt examination.
 - e. **Location:** The candidate must locate a secluded/undisturbed noise free & comfortable properly illuminated corner in his home having stable power supply, the hardware and internet connection. Participants are required to produce photo identity at the beginning of each module session as these will be recorded and logged for attendance.
3. **Examination:**
 - a. **Written Multiple Choice Questions (MCQ)** will be using software for online answering with time limit. During the examination the candidate may be required to activate the camera and microphone to facilitate E-Invigilation if required. No other person is allowed in the room during the one hour examination. Mobile phone connection to be switched off unless used for internet connection through Hotspot. The detailed procedure for the online examination will be intimated before the examination
 - b. **Scope of Questions:** will be based on the IAB Guideline 252r5-19 contents and in turn which will be selectively covered by the 20 modules during the refresher course.
 - c. **Difficulty level:** A qualified candidate engaged in the welding profession with practical exposure and after prior study of the lessons provided and paying attention to the lectures is not expected to face problem in answering.
 - d. **Oral Examination/Interview:** For each Transition Arrangement written exam/referred to 3 above, it will be mandatory as per Ref Clause 2 of IAB-ASS-065-April 20 to have an oral exam (video conference is acceptable) by an approved team of expert examiners.
 - i. The goal of the oral will be to verify if the examinee that has done the written exam has the knowledge at the level shown on the answers of the written exam.
 - ii. Will also discuss the candidate's current knowledge in his place of work and also beyond to fulfill the competency requirement of the qualification applied.
 - e. **Condition for award of Diploma:** The candidate has to be successful in both the written and Interview to be eligible for the diploma for which he fulfilled the eligibility.
 - f. **Re-examination/Downgrade:** At the discretion of the Examination Board after review the candidate may be offered a lower level qualification say IWT in place of IWE. The candidate may exercise this option or if allowed may apply for re-examination after fulfilling certain conditions.
4. **Award of Diploma:** The Diploma of International Institute of welding will be issued after the examination is over and there are no irregularities reported during E-Invigilation. Any negative report will make the candidate ineligible for any IIW Diploma apart from any other action that may be deemed necessary.
