ACTIVITIES OF THE INSTITUTE IN GENERAL

Though the major programmes of the institute were done with physical presence in the year 2024-25, but most of the meetings and lectures (webinars) conducted virtually. Most of the IIW-India Branches conducted various important programmes during the year under consideration. The yearlong activities were as follows:

*** COUNCIL MEETINGS**

The IIW-India Council held five (05) Meetings (336th to 340th) during the year under consideration. Apart from the regular agendas, some important decisions were taken during the Council meetings, of which formation of Ahmedabad Centre under the aegis of Baroda Branch was most significant. Other important decisions were to organise the following events:

- Young Professionals' International Conference (YPIC INDIA-2025) at Delhi in 2025,
- International Welding Research Collaboration Colloquium (IWRCC-2026) at Chennai in 2026,
- International Congress (IC-2027) at Baroda in 2027
- IIW Annual Assembly and International Conference in 2028, (subject to the approval by IIW Board of Directors) for which the request has been placed to the Secretariat of International Institute of Welding (IIW), however, venue is yet to be finalised.

*** IIW-INDIA RECOGNITION AND AWARDS 2024-25**

Lifetime Achievement Award 2024: This award was given to Mr. R. Srinivasan, Past President (2014-2017), IIW-India, and Vice President, International Institute of Welding, in recognition of his selfless devotion and dedicated contribution to the institute for promotion of welding science and technology in India for the last 50 years and still continuing. He was also the interim President of the institute to take the responsibility during the period from May to September 2021, after sudden demise of Parimal Biswas, the then President of the institute. Award: A Silver salver and a Citation.

Sir L. P. Misra Memorial Lecture 2024: This lecture was delivered by Dr. Renu N. Gupta, Head, Welding Technology & Enterprise Risk Management of Modification Revamp and Upgrade (MRU) Business, Larsen & Toubro Limited, Heavy Engineering Division, Mumbai. This was awarded for her outstanding contribution to the institute and for the promotion of welding science and technology in India specifically to the emerging youth. She delivered her lecture on the subject 'Key Drivers of Innovation in Welding-An Industry Perspective'.

Award: A Silver medal, sponsored by M/s Ador Welding Ltd., Mumbai and a Citation.

Prof. Placid Rodriguez Memorial Lecture 2024: This lecture was delivered by Dr. R. G. Rangasamy, Scientific Officer, Sodium Systems & Piping, Technical Directorate, PFBR, Bharatiya Nabhikiya Vidyut Nigam Limited (Bhavini), Department of Atomic Energy, Kalpakkam-603102, Tamil Nadu. This was awarded to him for his significant contribution for development of welding science and technology in India as a young scientist. He delivered his lecture on the subject 'Tracing drawings to technological demonstration by time tested welding and fabrication techniques during construction & commissioning of Prototype Fast Breeder Reactor (PFBR)'.

Award: A Certificate and a cash prize of Rs. 10,000/-, sponsored by IIW-India Chennai Branch.

Minati Bhattacharjee Memorial Award for the Best Performing Branch 2023-2024: In accordance with the revised criteria formulated, IIW-India Chennai Branch and IIW-India Mumbai Branch jointly won the award for the year under consideration, proposing maximum number of Membership Applications and smooth functioning of various activities of the Branch.

Award: A Trophy and a cash prize of Rs. 5,000/- each to both the Branches, sponsored by Late Ratish Ranjan Bhattacharjee.

Apart from the above, several other awards and prizes were handed over to the winners, which are described later in the particular section of this report.

❖ REPORT OF THE NATIONAL WELDING MEET 2024 (NWM-2024)

The Indian Institute of Welding, Kolkata Branch organised the National Welding Meet (NWM-2024) during 26th& 27th September 2024 at hotel The Stadel, Salt Lake Stadium, Kolkata-700098, on the theme 'Advanced Welding Technologies for Sustainable manufacturing — Leveraging Industry 5.0'. The programme was inaugurated by the Chief Guest Mr. Ravi Todi, Managing Director, BTL-EPC Ltd., in presence of the Guest of Honour Mr. Anupam Shah, Jt. MD, Nipha Exports Pvt. Ltd. A total of around 100 participants attended the Meet.

After the Inaugural ceremony, two Memorial Lectures have been delivered. John Abraham Muliyil Memorial Lecture on 'Improved Health Standards through Reduction of Hazardous Contents in the Welding Fume' by Mr. Abhishek Vyas of M/s. voestalpine Bohler Welding India Pvt. Ltd., Mumbai and Engineer Soumitra Kumar De Memorial Lecture on 'Implementing Welding Automation in the MSME Segment: Enhancing Efficiency and Competitiveness' by Mr. Devasis Paul of M/s. Nextgen Plasma Pvt. Ltd., Kolkata.

Post Lunch, a Plenary Session on Skill Development & National Welding Capabilities has been organised, chaired by Mr. Jose P. Philip, President-Elect, IIW-India. The Speakers in this Sessions were Mrs. Varsha Tibrewal, Asst. Director (Training & Operations), Indian Iron & Steel Sector Skill Council (IISSSC); Mr. Anindya Chakrabarti, Sr. Director & Head (KKBO-2), Bureau of Indian Standards; Mr. Ramesh Shankaran, Regional Director, International Certification & Accreditation, AWS; and Mr. Rituraj Bose, Quality Management Consultant& Honorary Secretary General, IIW-India.

Thereafter, a Panel Discussion on 'Sustainable Manufacturing' has been arranged and chaired by Dr. Mahadev Shome, CEO ANB-India & Scheme Manager, ANBCC-India. The Panelists were Cdr. Arun Kumar Mahapatra, IN (Retd), Ex GM, GRSE Ltd., Mr. Gyana Ranjan Mohanty, CEO, Corrosion Protection Pvt. Ltd., Prof. Dr. Amitava Gupta, Professor (Power Engg.) & Ex Director (School of Nuclear Studies & Applications), Jadavpur University.

On 27th September 2024, 4 Technical Sessions have been organised with 5 Invited papers and 6 contributed papers on varied subjects. The paper of Mr. Nikhil Shajan of TATA Steel Limited, titled 'Effect of coating resistance on the mash seam weldablity of secondary coated steels' has been adjudged as the Best Presented paper and the recipient of AWPM Award.

REPORT OF THE ARC CUP INTERNATIONAL WELDING COMPETITION 2024

Organising Committee of BRICS Skills Development and Technology Innovation Competition – Arc Cup International Welding Competition, organised the ARC Cup International Welding Competition every year and IIW-India is participating in this competition since 2016. The Winners and the Runners-up of the IIW-India organised National Skill Competitions are eligible to take part in this competition. In 2024, the ARC Cup International Welding Competition was held in Gu'an County, Langfang City, China, between 25th to 30th October 2024. Three Welders along with Team Leader Mr. Rituraj Bose, Coordinator Mr. Abhishek Vyas and coach of one competitor Mr. Vignesh Maharajan attended the competition physically. Further, three candidates participated in virtual mode in Welding Technology Competition.

Team India has bagged the Silver Cup in the Competition. All the 3 competitors of Welding Skills Competition and 3 competitors of Welding Technology Competition were felicitated during the National Welding Seminar 2024 at Jamshedpur.

REPORT OF WELDED MARVELS 2024 – PROJECT TRASH TO TREASURE

For the fourth consecutive year, the amateurs of various spheres participated in the National Competition on Welded Marvels – Project Trash to Treasure, which was organised by IIW-India during November 2024. This competition aims to produce sculptures as social intervention, to inspire awe and joy, to educate, and to alter attitudes of viewers. IIW-India, with Association of Welding Products Manufacturers (AWPM), have jointly organised this competition, which is ably supported by M/s. Ador Welding Ltd.

REPORT OF THE NATIONAL WELDING SEMINAR 2024 (NWS-2024)

One of the flagship events of IIW-India, National Welding Seminar (NWS-2024) was organised at SNTI, Jamshedpur from 12th-14th December 2024, hosted by IIW-India Jamshedpur Branch. The theme of the seminar was 'Advances in Welding, Cladding and Additive Manufacturing'. The Chief Guest of the seminar was Mr. Probal Ghosh, VP, One Shared Services, Tata Steel and the Guest of Honour was Mr. M. Sankaranarayanan, ED, Operations, RSB Transmissions. The Inaugural Session was presided by Mr. Jose P. Philip, President, IIW-India.

During the 3 days, 108 contributory technical papers were presented. Key areas of presentations included recent developments in the field of arc welding, resistance welding, laser welding and electron beam welding. Further, numerous presentations on the potential and actual application of weld overlay and laser cladding were made, that were highly relevant for wide range of industries including steel, oil & gas, nuclear and automotive sectors. Different dedicated sessions on additive manufacturing etc. were also organised to cover various areas of welding technology. Presentations were also made by the representatives from industries like Tata Steel, ISRO, John Deere, L&T, Hoganas, Welding Alloys, voestalpine Bohler etc., whereas Scientists from National Labs like CSIR-NML, CSIR-CMERI, BARC, IGCAR etc. were participated in the event.

There was significant representation of Faculty members and research scholars from academic institutions including IIT Bombay, IIT Madras, IIT Kharagpur, IIT BHU, IIT Roorkee, IIT Guwahati, IIT Pallakad, Jadavpur University, NIT Jamshedpur, VIT Vellore, Annamalai University and many others. Apart from contributory presentations, there were three (3) plenary talks and thirteen (13) keynote talks. Plenary talks were delivered by Mr. Christophe Gregoir (Global Head of UTP Surface Protection and Managing Director voestalpine Bohler Welding Belgium S.A.), Prof. Amitava De (IIT Bombay) and Dr. Sandip Ghosh Chowdhury (Director, CSIR-NML).

Furthermore, a Plenary Session on 'National Welding Capability and Skill Development in Welding' and a Panel discussion on 'Welding and Beyond' were conducted on the first day. The Plenary Session was chaired by Mr. Jose P. Philip, President, IIW-India, and the speakers were Mr. Sushim Banerjee, Indian Iron and Steel Sector Skill Council, Mr. Rituraj Bose, Hony. Secretary General, IIW-India and Prof. Vishvesh Badheka, Pandit

Deendayal Energy University. The Panel discussion was moderated by Prof. Santanu Das and the panelists were Mr. Kalyan Prasad, Prof. V. Balasubramanian, Dr. Rakesh Goyal, Mr. Brajesh Chhabra and Mr. A. Dutta Roy.

Apart from these enriching technical talks, 16th Weld India Exhibition featuring more than 20 latest technologies and products from various welding and allied technology providers was a major center for attraction. The three-day seminar also included a grand open air cultural program which served as a light moment for 300+ delegates. In totality, the NWS-2024 proved to be a hugely successful event that updated the participants with the most up-to-date knowledge on the theme of the seminar, as well as allowed for remarkable networking.

The best presented paper of the seminar was declared during the valedictory session, authored by Mr. Diljith P. K. of IIT Bombay, et al.

After thorough peer-review, a special issue of selected papers from NWS-2024 was published in Welding International (Taylor & Francis) Journal.

REPORT OF INTERNATIONAL COMMITTEE

Report of 77th IIW Annual Assembly 2024

The 77th IIW Annual Assembly of the International Institute of Welding (IIW) was held from 7-12 July 2024 at Rodos Palace Hotel, Rhodes, Greece, where 41 out of 51 member countries joined the Annual Assembly for the proceedings, with more than 1000 delegates registered, which is a record after around 25 years!

The Indian Institute of Welding (IIW-India) delegation comprised of Mr. Deepak V. Acharya - President and Mr. Rituraj Bose - Hony. Secretary General. Apart from the above, another 11 persons from India joined the Assembly, which includes 5 PhD scholars. There were some non-resident Indians too, those who have joined the Assembly and some of them are the members of IIW-India.

The General Assembly was conducted on 7th July, where Mr. Deepak V. Acharya and Mr. Rituraj Bose were the representatives from India. It is indeed a very good news that Mr. Anil V. Parab, Whole time Director & Sr. Executive Vice President, L&T Ltd., was declared as the member of IIW Advisory Council. Further, Mr. Hitesh Narsia of IIW-India has been declared as the Future Leader of the International Institute of Welding and will be a member of IIW Board of Directors for one year (without voting rights). During the opening ceremony, the winner of various awards of IIW has been announced, followed by a dinner.

Working Group - Regional Activities (WG-RA)

On 7th July, there was WG-RA Meet after the Annual Assembly, where many countries presented their activities. From India, Mr. Rituraj Bose presented the report of IIW-India, which includes IC-2024 and future programmes. Also, the digital collection of Welded Art Photographic Exhibition was released during the WG-RA Meet, where few of the Indian works were displayed.

Ice Breaking Session & Young Professional Meet

On 7th of July, an Ice Breaking Session was conducted for the Young Professionals and Students, where they were interacted with each other, and the Indian delegation of that category was also present to feel the warmth of Annual Assembly. Later on, 8th July, there was Working Group - Young Professionals (WG-YP) Meet, where Mr. Adarsh Prakash represented IIW-India.

IAB (International Authorisation Board) Meetings

Mr. Rituraj Bose and Mr. Deepak V. Acharya attended the IAB meetings on behalf of ANB-India and ANBCC-India. In IAB Group-A meeting on 8th July, ANB-India's suggestion was approved during the WG A#8a report for Alternate Route. In IAB Group-B meeting on 9th July, ANBCC-India's corrections for log of changes were

mentioned during the WG B#6 and assurance provided to incorporate the comments while revising IAB-339 document. IAB Members Meeting was conducted on 10th July.

Different Commissions, Symposium and International Conference

All the Indian delegates were busy with attending different Commissions, Intelligent Welding Manufacturing Symposium, and International Conference. Many of them presented their papers between 8th to 11thJuly. It is notable that this time around 10 papers were presented in different commissions and International Conference by the Indian PhD scholars and other professionals, apart from the NRIs.

Meeting with IIW Secretariat, Indian Delegation and American Welding Society

Mr. Deepak V. Acharya and Mr. Rituraj Bose had a meeting with Dr. Luca Costa, CEO of International Institute of Welding (IIW) on 9th July. IIW-India's preliminary proposal of hosting a stand-alone Young Professionals' International Conference in 2025, International Welding Research Collaboration Colloquium in 2026, International Congress during early 2027 and 81st IIW Annual Assembly in 2028 were placed to Dr. Luca Costa, which will be finalised by IIW-India Council and then the request letters will be sent to IIW.

A meeting was organised with the Indian delegations and NRIs on 10th July, to meet each other and explain the activities of IIW-India through a presentation. It was a nice interaction with them and NRI Mr. Jithesh P. K. from Saudi Arabia became the member instantly.

On the same day, i.e., 10th July, Mr. Deepak V. Acharya and Mr. Rituraj Bose held another meeting with American Welding Society (AWS). AWS representatives including President and Vice President, were showed their interest to launch a dual certification programme in India for Certified Welding Inspectors along with IIW-India's National Welding Inspectors' Certification Scheme.

It was a wonderful experience altogether toattend 77th IIW Annual Assembly. IIW-India has interacted a lot with others and the presence of India was evident. Also, few of the industries, those who have given their stalls in the Exhibition area, were expressed their interest to have collaboration with India.

As informed, the 78th IIW Annual Assembly will be held in Genoa, Italy from 22-27 June 2025.

AM-IIW Examination

Summer Session AM-IIW Examination 2024-25 was held between 13th to 21st of July 2024 on Saturdays and Sundays by pen & paper method under online supervision. • IIW / IAB Meetings

77th IIW Annual Assembly from 7th to 12th July 2024:

Both Mr. Rituraj Bose and Mr. Deepak V. Acharya attended the IAB meetings on behalf of ANB-India and ANBCC-India.

The brief outcome of IAB Group A, Group B, and Members Meetings are as follows.

Group-A (Education, Training & Qualification) meeting on 8-07-2024:

In IAB Group-A meeting on 8th July, ANB-India's suggestion has been approved during the WG A#8a report for Alternate Route.

The favorable log of changes made in the IAB-442 Guidelines are:

- i. ANB approved course' included as a training mode alternative to ATB.
- ii. Technical interview of 2 hrs. recommended' in place of compulsory 2 hrs.
- iii. The purpose of the Technical Interview is to verify the accuracy of the information on the application' and is not an assessment of knowledge. This has been applied uniformly in all Modules of Appendix III.

Group-B (Implementation, Authorisation and Certification) meeting on 9-07-2024:

In IAB Group-B meeting on 9th July, a discussion was done for the digital certification system of diplomas during the presentation of Task Force WG B#2. Also, ANBCC-India's corrections for log of changes were mentioned during the WG B#6 and assurance provided to incorporate the comments while revising IAB-339 document. Thereafter a workshop was organised for IIW-IAB Accreditation in accordance with ISO 17024 and ISO 17065, so that members can be well acquainted with the same.

IIW Members Meeting on 10-07-2024:

As per IIW-India's proposal to explore the possibilities of reducing the Audit fees during the 2023 Assembly, no assurance was given, but assurance provided that one of the 2 Auditor will join virtually and hence will reduce the cost of travel etc. During informing the marketing strategy, Dr. Luca Costa, CEO of IIW, informed that a Stakeholders Meet will be organised from 2025 Assembly onwards to provide a forum to all the member societies.

• International Welding Coordination Personnel (IWCP)

Standard Route:

ANB-India Approved Training Body, Cornerstone Academy Pvt. Ltd. (CAPL), Chennai, has completed the IWE/IWT (International Welding Engineer / International Welding Technologist) course of 14th Batch of 47 candidates in physical mode. The examination was conducted during August 2024 and results declared.16 out of 47 candidates have been awarded Diplomas at their respective level. The 15th Batch (IWE/IWT) Course started in September 2024 with 16 candidates.

24 Standard Route candidates have also appeared in IIW/Exam/01/2025 Combined Examination (Standard & Alternative Routes) in January 2025, out of which 7 candidates are qualified and are eligible for the Diplomas at their respective level.

Alternative Route:

The 17th Alternative Route Examination with 22 candidates conducted in February 2024, and 14 out of 22 candidates have been awarded Diplomas at their respective level in 2025-26.

The 18th Alternative Route Examination with 20 candidates conducted in June-July 2024 and 8 out of 20 candidates have been awarded Diplomas at their respective level.

The 19th Alternative Route Examination with 18 Candidates has been conducted during January 2025 simultaneously at three physical Centers of Baroda, Chennai and Kolkata under direct ANB invigilation. 9 out of 18 candidates are qualified and are eligible for the Diplomas at their respective level.

Transition Route:

The 98th IWCP Refresher Course under Transition Route in Online mode has been conducted during November-December 2024, with 29 fresh and 18 re-appearing candidates. 26 out of 47 candidates have been awarded Diplomas at their respective level.

Some of the Alternative Route candidates attended Refresher Course Online (98 RC) along with Standard Route candidates, to enhance their knowledge prior to attending the Examination.

• IIW-India Product Certification (IIWIPC) Accreditation Status and benefits

- Quality documents (complying to ISO 17065, ISO 17067 and ISO 3834) as the Product Certification Body (PCB) were submitted to NABCB in May 2024.
- NABCB has assigned the task to an expert (auditor) to review the application in August 2024 and review report received for further action.
- ➤ If accredited by NABCB (National Accreditation Board for Certification Bodies), the PCB can approach government organizations like Railways, Defence etc. for ISO 3834 certification.
- ➤ Initially the accreditation is for three levels of ISO 3834. In the next stage authorization will be sought for EN 15085, EN 1090 etc. It is expected that Indian Industries would increasingly like to go for these certifications as the nation progresses.
- > Accreditation will help in promoting both IIW-MCS and IIWIPC certification together. Moreover, an organization may be offered both the certificates through a single audit at a discounted premium price.
- > If accredited, IIWIPC will be the first Indian certification body to offer ISO 3834 Certificates to Indian manufacturing organisations.

- a) in our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books.
- b) the Balance Sheet, the Statement of Income and Expenditure dealt with by this Report are in agreement with the books of account.
- c) in our opinion, the aforesaid standalone financial statements comply with the Accounting Standards prescribed under section 133 of the Act read with rule 7 of the Companies (Accounts) Rules, 2014.
- d) on the basis of the written representations received from the directors of the Company as on March 31st 2025 taken on record by the Board of Directors, none of the directors is disqualified as on March 31st 2025 from being appointed as a director in terms of Section 164(2) of the Act.
- e) with respect to the adequacy of the internal financial controls over financial reporting of the Company and the operating effectiveness of such controls, refer to our separate Report in "Annexure A". Our report expresses an unmodified opinion on the adequacy and operating effectiveness of the Company's internal financial controls over financial reporting.

SIGNIFICANT ACCOUNTING POLICIES & NOTES ON ACCOUNTS

5.1 Convention:

The financial statements have been prepared in accordance with applicable accounting standards in India. Financial statements have also been prepared in accordance with relevant requirements of the Companies Act 2013.

5.2 Basis for preparation of Accounts:

The Accounts are prepared under the historical cost convention unless otherwise stated and generally on the accrual method of accounting.

5.3 Depreciation:

Depreciation amounting to **INR. 1,186,290.22** have been charged as per Companies Act 2013 on Written Down Value method. There is no change in the method of depreciation from previous year.

5.4 Fixed Assets:

Fixed Asset is accounted on the basis of Acquisition Cost and other direct cost attributable for the acquisition of Fixed Asset.

5.5 Deposits with Banks:

Deposits are made only in Fixed Deposits of Nationalised Bank and are valued at cost plus accumulated interest wherever applicable.

5.6 Borrowings:

Long Term Borrowings from others is unsecured and terms and repayments have not been stipulated.

5.7 Income:

- i) Subscription advertisement, seminars and examinations (held in branch and head quarters) are considered as part of income.
- ii) Membership fees are accounted for on cash basis. Advance Membership fees are accounted in Accrual basis and charged to revenue in the respective years in future.
- iii) Income from Deposits is included in the Income & Expenditure account on accrual basis unless specifically mentioned.

5.8 Retirement benefit:

- i) Provident Fund has been regularly deducted and deposited in due time.
- ii) The Institute does not provide for gratuity in its revenue statement as it has only 1 permanent employee. Gratuity is accounted and paid in the year in which it actually incurred.

5.9 Expenses:

- i) Expenses are accounted on accrual basis unless specifically mentioned otherwise.
- ii) No provisions for Income Tax on Income from deposits has been made in the accounts as the Institute has got the recognition as "Institute for Charitable Purpose" under Section 12A of the Income Tax Act 1962 vide Certificate dated 17-02-1986 from Commissioner of Income Tax West Bengal-VII. Hence no provision has been made for Income Tax in the accounts for the FY 2024-25.

5.10 Auditors Remuneration:

Statutory Audit Fees for **FY 2024-25: INR. 78,540/-** (includes INR. 540/- for last year GST ITC reversal adjustment).

5.11 Directors Remuneration:

All the Directors of the Institute hold Honorary posts in the Institute and no remuneration is paid to them during the year.

- **5.12** The Institute is registered as a "not for profit company" under section 25 of Companies Act 1956 (presently section 8 of the Companies Act 2013). Accordingly, no activities are carried on by the Institute which are related to Profit motive purpose.
- **5.13** Previous year figures have been rearranged and regrouped wherever necessary.
